

**EASTON BOARD OF SELECTMEN

MINUTES**

PRESENT: Chairman Mike Corey, Paul Dudley, Doug Blackstone, Bruce Flewelling, Scott Allen, Richard Green and Jim Gardner Town Manager.

Chairman Corey called the regular meeting to order at 7:00 pm

Selectmen Dudley made the motion to approve minutes of the 13 March 2017 Regular Meeting. Selectmen Flewelling seconded the motion. Motion carried 5-0.

Selectmen Blackstone made the motion to approve and sign treasurer's warrants #9 through #17. Selectmen Dudley seconded the motion. Motion carried 5-0.

Selectmen Allen made the motion to sign the abatement request for Rita Henderson. Selectmen Flewelling seconded the motion. Motion carried 5-0.

Selectmen Flewelling made the motion to approve moving the moratorium on marijuana ordinance to public hearing after meeting with representative from Maine Municipal Association legal or legislative advocate. Selectmen Dudley seconded the motion. Motion carried 5-0

Selectmen Dudley made the motion to table the approval of a tax anticipated note from a financial institution until all bids are in. Selectmen Blackstone seconded the motion. Motion carried 5-0.

Selectmen Dudley made the motion to approve and sign annual appointments of municipal officials. Selectmen Flewelling seconded the motion. Motion carried 5-0.

During the Town Manager's Report Town Manager Jim Gardner informed the Easton Board of Selectmen that there was concern with the tractor excise tax system and the calculations of the systems tractors. Easton Board of Selectmen asked the Town Manager to see how it is handled in other communities. Town Manager Gardner stated that a concern citizen was inquiring about the Union Church located on the Ladner Road. After a short discussion the Easton Board of Selectmen asked Town Manager Gardner to take a photo of the existing building.
