Selectmen Dudley made the motion to pay Cheryl Clark for accumulated vacation time (52 days) a sum of \$9,792.64 from Article 36 of the approved 2017 Town of Easton warrant or to give the option of carrying that total forward until her retirement. Selectmen Allen seconded the motion. Motion carried 5-0

Town Manager Jim Gardner informed the Easton Board of Selectmen that all of the Easton School Department's accounts with the Town of Easton's Employee Identification Number located at Katahdin Trust Company have been transferred to the new identification number. Town Manager Gardner showed the Easton Board of Selectmen a full page article that will appear in the Star Herald showcasing Easton's strengths as a community to live in. Town Manager Gardner informed the Easton Board of Selectmen that the Town of Easton had tax acquired a piece of property located on the Richardson Road and there was a mobile home belonging to another individual that currently sits on the lot. Town Manager Gardner stated that he would be working with the Town Attorney to remediate the problem.
